- 3. Copies of the records of the IP addresse(s) for each computer identified in request #1 above.
- 4. Copies of the records of the IP addresse(s) for each cell phone identified in request #2 above.
- 5. Copies of the records of all communications, including without limitation emails, text messages, letters, etc either sent to, received by, or copied to, between any District 81 School Board member and James J. Tompson over the last twelve months.
- 6. Copies of the records of all communications, including without limitation emails, text messages, letters, etc either sent to, received by, or copied to, between any District 81 employee including administrators and James J. Tompson over the last twelve months.

¹ "Public records" means all records, reports, forms, writings, letters, memoranda, books, papers, maps, photographs, microfilms, cards, tapes, recordings, electronic data processing records, electronic communications including e-mails, recorded information and all other documentary materials pertaining to the transaction of public business, regardless of physical form or characteristics, having been prepared by or for, or having been or being used by, received by, in the possession of, or under the control of any public body.
